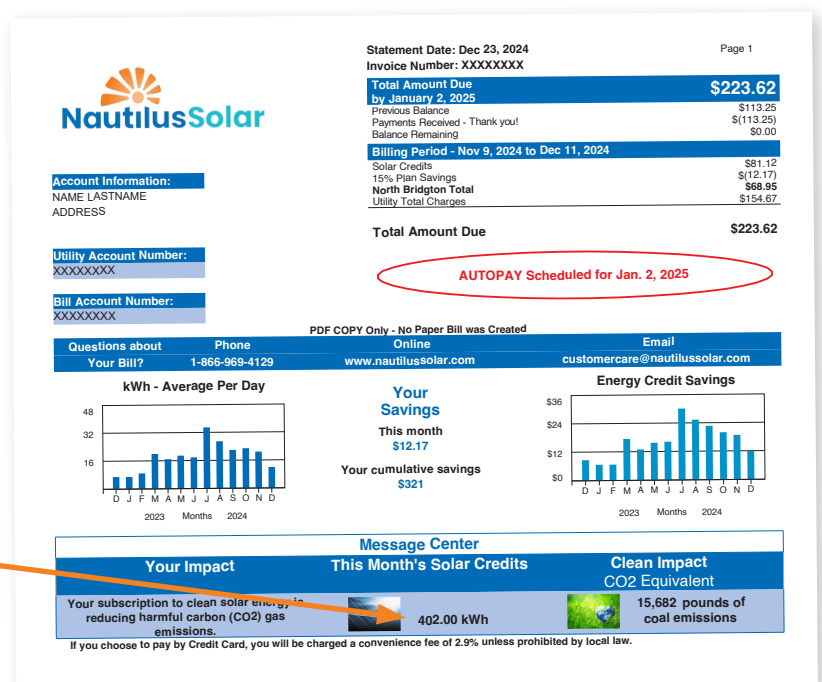




BILLING EXPLAINED FOR MAINE SUBSCRIBERS WITH CENTRAL MAINE POWER

As a Maine resident, you have elected to receive the consolidated bill option. Each month, Nautilus will pay your total utility charges directly to your utility company on your behalf. In turn, you will receive a monthly statement from Nautilus which details your CMP utility charges, your solar energy credits for your share of the solar farm, and your discount.

Remember, solar credits are not free. They are a way for residents to pay for a portion of their energy consumption at a discount while also producing clean, renewable energy.



BILL EXAMPLE

In the example shown, this customer's share of the solar farm generated 402 kWh of renewable energy for the month which calculates to \$81.12. Then, Nautilus provided a 15% discount (\$12.17), dropping the bill for solar credits to \$68.95.

This subscriber also owes \$154.67 for CMP delivery fees and any additional energy beyond what was generated by the farm allocation, bringing the total amount owed to \$223.62.

Sometimes a solar farm generates more than what is needed in a particular month. In these cases, the subscriber is required to pay for all generated credits, but the credits roll over to be used in the subsequent months when solar generation may be lower.

WHAT WOULD THE BILL HAVE BEEN WITHOUT NAUTILUS COMMUNITY SOLAR?

\$235.79 (\$12.17 SAVED)

This subscriber **saved \$12.17 on their monthly utility bill**. These monthly savings may seem small, but they add up over the course of the year!



RECONCILING STATEMENTS WITH YOUR UTILITY BILL

Looking for more detail? You will still receive a statement from CMP every month for your records, so you can always check this information. (Remember to compare the same billing period!)

A few tips to understand your utility bill and your solar credits:

- ✓ A CMP utility bill consists of **supply charges** and **delivery charges**. **Usage** refers to the amount of energy consumed by your household.
- ✓ **Allocated Generation** is the amount of energy produced by your portion of the solar farm. This is the portion of energy that is paid for at a discount (15%).
- ✓ Any difference between the Usage and Allocated Generation is charged at standard CMP rates. These rates are subject to change at the discretion of CMP, but Nautilus commits to keep your discount at 15%.

Delivery Charges = Usage - Allocated Solar Generation

1,022 kWhs - 402 kWhs = 620 kWhs

Per CMP, the first 50 kWhs of a customer's bill are incurred at a flat rate of **\$26.60**. The remaining amount is billed at \$0.108980/kWh. In this example the 570 kWhs @ \$0.108980 = **\$62.12**. **Total Delivery charges = \$88.72**

Supply Charges

The subscriber was billed 620 kWhs at \$0.106363 = **\$65.95**.

Total Bill = Delivery + Supply + Discounted Solar Credits

\$88.72 + \$65.95 + \$68.95 = \$223.62 as seen on the Nautilus bill. Again, without the solar credits, this subscriber would pay \$235.79.
