Ultimate Power Play Sweepstakes - Official Rules

1. Eligibility:

The Ultimate Power Play Sweepstakes (the "Sweepstakes") is open to legal residents of the state of Maine who are 18 years of age or older at the time of entry. Employees, officers, directors, agents, and representatives of Nautilus Solar Energy®, LLC ("Nautilus"), and their immediate family members and household members, are not eligible to participate. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law.

2. Sweepstakes Period:

The Sweepstakes begins on September 1, 2024, at 12:00 AM Eastern Time ("ET") and ends on August 30, 2025, at 11:59 PM ET (the "Sweepstakes Period"). Entries must be received during the Sweepstakes Period to be eligible.

3. How to Enter:

To enter the Sweepstakes, you must:

a. Automatic Entry through Subscription:

Participants who subscribe to Nautilus community solar by using the code MARINERS during the Sweepstakes Period will automatically receive one (1) entry into the Sweepstakes for the corresponding monthly prize drawing based on their enrollment date. Each entry is also eligible to win future monthly prizes for the duration of the Sweepstakes Period.

b. Entry for Existing Subscribers:

Existing subscribers to Nautilus community solar are not eligible to enter the Sweepstakes but will be automatically entered in a Maine Mariners ticket giveaway. Prize to include a four-pack of tickets to one (1) Saturday or Sunday home game for the 2024/2025 season. Four (4) prizes will be awarded. Subscribers must be entered by February 28, 2025, to be eligible.

c. Alternative Method of Entry (AMOE):

Mailed entries must be received by August 30, 2025. Only one entry per person.

4. Prize Details: All participants who enroll in Nautilus community solar between September 1, 2024, and August 30, 2025, will be automatically entered into the Sweepstakes to win monthly prizes and the grand prize.

 - **Winner Selection Date:** January 1, 2025.
- **January 2025:**
 - **Eligibility:** Enroll between September 1, 2024, and January 31, 2025.
 - **Prize:** One (1) person will win one (1) custom jersey and one (1) autographed stick.
 - **Winner Selection Date:** February 1, 2025.
- **February 2025:**
 - **Eligibility:** Enroll between September 1, 2024, and February 28, 2025.
 - **Prize:** One (1) person will win one (1) autographed jersey and one (1) autographed stick.
 - **Winner Selection Date:** March 1, 2025.
- **March 2025 (Grand Prize):**
 - **Eligibility:** Enroll between September 1, 2024, and March 7, 2025.

5. Winner Selection and Notification:

Winners will be selected in a random drawing from all eligible entries received during the Sweepstakes Period. Drawings will be held monthly, and winners will be notified by phone, email, or mail within five (5) business days of the drawing. If a winner cannot be contacted within seven (7) days of the first attempt to contact them, or if they are found to be ineligible, an alternate winner may be selected.

6. General Conditions:

By participating, entrants agree to abide by these Official Rules and the decisions of Nautilus, which are final and binding. Nautilus reserves the right to disqualify any entrant it finds to be tampering with the entry process or to be acting in violation of these Official Rules.
